#### **Rules and Regulations**

Registration the day of will be held

from 8:00 am-9:45 am

Open Canoes will be categorized as "standard" or "unlimited" depending upon hull design and materials of construction.

Any other modifications, other than flotation, below the rails that impede water from entering the canoe is subject to disqualification.

Open Canoes must be propelled with single bladed paddles. Bent-shafts are permissible and encouraged in all classes.

PFD's with safety whistles must be carried in all boats. All competitors in the youth class are required to wear PDFs throughout the duration of the event. Use of PDFs by ALL competitors is strongly encouraged and may be required if conditions warrant.

\*No racing canoes in recreation classes.

### DIRECTIONS

Take I-180/220 to Williamsport, PA.

**180 Westbound** take the Third Street/Warrensville Road exit #23. Turn left at the bottom of the ramp (towards Montoursville). At first light, turn right onto Old Montoursville Road. Follow signs to Riverfront Park/Greevy Boat Access.

**180 Eastbound** take the Third Street/Warrensville Road exit #23B. At the light at bottom of ramp turn right onto Old Montoursville Road. Follow signs to Riverfront Park/Greevy Boat Access.

# The Course

There will be two separate races. Each race will be approximately 6.3 miles in length. This year each race will consist of 2 smaller loops to allow spectators a better view.

The Flatwater Challenge runs over the beautiful waters of the "Long Reach" of the West Branch of the Susquehanna River. Paddlers will start at the Greevy Boat Launch in Historical Riverfront Park and paddle upstream to the first buoy. A clockwise turn will send you down-river to to the second buoy. The course splits for the downriver leg. Recreation classes will follow the

downriver leg. Recreation classes will follow the main channel and river permitting, racing classes will take in the tight confines of the Sylvandell Gut. Use this lush technical section to increase your lead and lose that trailer or close in on the competition. The race finishes back at the Boat Launch.

A map of the course will be available the day of the race.
