ORDINANCE NO. 2018-389

AN ORDINANCE OF THE TOWNSHIP OF LOYALSOCK, LYCOMING COUNTY, PENNSYLVANIA, AMENDING CHAPTER 205 VEHICLES AND TRAFFIC OF THE CODE OF ORDINANCES OF THE TOWNSHIP OF LOYALSOCK BY AMENDING SECTION 205-17 CLOSING OF CERTAIN STREETS TO CERTAIN VEHICLES RESTRICTING TRAFFIC TO ONLY PASSENGER CARS ON SECTIONS OF FAXON PARKWAY, SHIFFLER AVENUE, LAFAYETTE PARKWAY, AND PENNSYLVANIA AVENUE

WHEREAS, the Township of Loyalsock (the “Township”) has the authority under the Second Class Township Code (53 P.S. § 65101) and the Pennsylvania Vehicle Code (75 Pa. C.S. § 101 et seq.) to regulate vehicle traffic on the roads within the Township; and

WHEREAS, the Township has the express authority under the Pennsylvania Vehicle Code (75 Pa.C.S. § 6109(a)(13) to prohibit or regulate the use of designated streets by any class or kind of traffic; and

WHEREAS, the Pennsylvania Vehicle Code (75 Pa.C.S. § 6109(e)) requires a local municipality to complete an engineering and traffic investigation when and in such manner as required by regulations promulgated by the Pennsylvania Department of Transportation (the “Department”); and

WHEREAS, the Department’s regulations on the restriction of a class or kind of traffic on designated streets are contained in Publication 212 Section 212.111 Turn Restriction Warrants; and

WHEREAS, Section 212.111 permits restrictions based upon crash history, capacity analysis or field review for certain indicated conditions; and

WHEREAS, the Township has conducted a field review and determined that the dimensions of sections of Faxon Parkway, Shiffler Avenue, Lafayette Parkway, and

Pennsylvania Avenue pose potential crash situations for through vehicles, property damage to adjacent properties and reduced corner sight distance; and

WHEREAS, the Township has determined that it is in the best interests of the safety and welfare of the Township citizens that traffic be limited to only passenger cars, as defined in the Pennsylvania Vehicle Code (75 Pa.C.S. § 102), on sections of Faxon Parkway, Shiffler Avenue, Lafayette Parkway, and Pennsylvania Avenue.

NOW, THEREFORE, be it hereby enacted and ordained as follows:

PART 1

Chapter 205, Vehicles and Traffic shall be amended to read as follows:

§ 205-17 Closing of certain streets to certain vehicles.

It shall be unlawful for any person to drive any vehicle, except a passenger car upon any of the following streets or the parts of streets herein designated:

<u>Name of Street</u>	<u>Limits</u>
Faxon Parkway (T-614)	Passenger cars (as defined in the State Vehicle Code) only from the legal right of way line of Washington Blvd. on the north side to the intersection with Sheridan Street.
Shiffler Avenue (T-634)	Passenger cars (as defined in the State Vehicle Code) only from the legal right of way line of Washington Blvd. on the north side to the intersection with Sheridan Street.
Lafayette Parkway (T-476)	Passenger cars (as defined in the State Vehicle Code) only from the legal right of way line of Washington Blvd. on the north side to the intersection with Sheridan Street.

Name of Street

Limits

Pennsylvania Avenue (T-472)

Passenger cars (as defined in the State Vehicle Code) only from the legal right of way line of Washington Blvd. on the north side to the intersection with Sheridan Street.

The above prohibition shall not apply to emergency vehicles, school buses and local deliveries (must have destination on the street that is otherwise restricted).

PART 2

All other provisions of Chapter 205 Vehicles and Traffic are hereby reaffirmed.


PART 3


